I. GENERAL INFORMATION

1. CONTROLLER

We, Porsche Lifestyle GmbH & Co. KG, take the protection of your personal data and the legal obligations related to this protection very seriously. The legal requirements require comprehensive transparency regarding the processing of personal data. Processing will only be transparent to you as the data subject if you are adequately informed about its purpose, type, and scope.

2. DEFINITIONS

6. NOTIFICATION OBLIGATIONS OF THE CONTROLLER

We will notify all recipients who have received your personal data of any corrections or deletions of your personal data, or any restrictions on processing pursuant to Articles 16, 17(1) and 18 of the GDPR, unless such notification is impossible or requires disproportionate effort. We will inform you about the recipients if you request this information.

7. OBLIGATION TO PROVIDE

Unless stated otherwise in the following details regarding the legal grounds, you are not required to provide personal data. However, in the cases of Article 6(1) sentence 1 letter b of the GDPR, the personal data is necessary for fulfilling a contract or for the conclusion of a contract. If you do not provide the personal data concerned, the fulfilment or conclusion of the contract

is not possible. If you do not provide the data in the cases of Article 6(1) sentence 1 letter a or letter f of the GDPR, the use of the respective service is not possible.

8. RIGHT TO OBJECT

You have the right to object at any time to the processing of your personal data based on Article 6(1) sentence 1 letter f of the GDPR for reasons relating to your particular situation; this also applies to profiling based on these provisions. If personal data is processed for direct marketing purposes, you have the right to object at any time to the processing of personal data concerning you for the purposes of such advertising; this also applies to profiling insofar as it is related to such direct marketing. The objection can be made in any form and should be addressed to our contact details stated above.

9. REVOCATION OF CONSENT

You have the right, according to Article 7(3) sentence 1 of the GDPR, to withdraw your consent at any time with effect for the future. This does not affect the legality of the processing carried out on the basis of the consent until the revocation. Upon your revocation, we will delete the personal data processed on the basis of your consent if there is no other legal basis for their processing.
